



Application Guidelines

Kobe City University of Foreign Studies & Monash University

In March 2015, KCUFS established a new Double Master Program with Monash University in Australia. This program is a postgraduate Master's program for English Studies majors, specializing in Interpreting and Translation Studies.

Students will enroll in the KCUFS Master's Program (Coursework + Research Project; Non-Thesis) and spend their first year at Monash University, followed by a year at KCUFS. On successful completion of the program, students will be awarded with Master's degrees from both universities.

1. Eligibility

First-round applicants for the KCUFS Master's program (Coursework + Research Project; Non-Thesis), English Studies major (Interpreting and Translation Studies) entrance examination may apply. Please note that second-round applicants are not eligible for this program.

- 2. Partner institution: Monash University (Wellington Road Clayton, Victoria 3800, Australia)
- 3. Intake: Maximum of five people

4. Program length

Two years

- First year: Monash University
- Second year: Kobe City University of Foreign Studies



5. Application requirements

Students must fulfill the application requirements for the KCUFS Master's Course and correspond to the following (1) and (2):

- (1) Degree: A Bachelor's degree with a major in English, linguistics, literature or the equivalent.
- (2) English Language proficiency: A combined score of over 95 for TOEFL iBT® (a minimum of 22 for Writing, 20 for Reading/Listening/Speaking), or a combined score of over 7 for IELTS Academic Module (a minimum of 22 for Writing, 6.5 for Reading/Listening, and 6 for Speaking).

6. Application procedure

Submit the required documents for the KCUFS Master's program (Coursework + Research Project; Non-Thesis) upon application.

7. Application period

There is an entrance examination (in the first application round) for the Master's program (Coursework + Research Project; Non-Thesis). For more information, please refer to the Application Guidebook.

8. Degree awarded

Students who satisfy the degree requirements for both universities will be awarded two Master's Degrees:


- Kobe City University of Foreign Studies: Master of Arts
- Monash University: Master of Interpreting and Translation Studies

9. Requirements

- (1) Kobe City University of Foreign Studies: Students must acquire 30 or more credits from compulsory class subjects, including:
 - 10 credits from Monash University, and 20 or more credits from KCUFS
 - A research project (submitted and assessed)
- (2) Monash University: Students must acquire 72 points from compulsory class subjects, including:
 - 48 points from Monash University, and 20 points from KCUFS
 - 160 practicum hours
- * Designated classes among those taught at Monash University will be credited (up to 10 credits) at KCUFS, and designated classes among those taught at KCUFS will be credited (24 points) according to the Monash point system.

10. Program content

The first year of the Master's program will be undertaken at Monash University, and the second year at Kobe City University of Foreign Studies.



• Upon completion of the program, students are able to obtain the Australian National Accreditation Authority for Translators and Interpreters (NAATI).

* Course structure

In the first year, students take designated classes at Monash University. Up to 10 credits may be acquired, and will be accepted as transfer credits by Kobe City University of Foreign Studies.

In the second year, students choose from Set(A) or Set(B), which they take with Set(C) over Semesters 1 and 2.

* Practicum

In the first year at Monash University, students must complete 160 hours of practicum during the academic year (the long break from November to March of the following year may also be used). Monash University will advise students of details regarding practicum, which consists of observing the work of professional interpreters at public institutions or private organizations, obtaining real-world translation experience and attending conferences in order to gain practical experience.

* Research project

In the second year at KCUFS, students must undertake a research project relating to either translation or interpreting during the academic year. Depending upon the direction of the translation (English into Japanese or Japanese into English), the project will be jointly supervised and assessed by teachers from KCUFS and Monash University (it is not possible to write a Master's thesis in this program).

- * Students of KCUFS will pay the above tuition fees directly to KCUFS for both years. Students are exempted from the payment of tuition fees to Monash.
- Students are responsible for all other visa application fees, as well as travel and living expenses.

12. Scholarship

At KCUFS, we have a scholarship system called the 'Ogino Scholarship', which offers assistance to outbound graduate and undergraduate students who are continually challenging themselves. Students chosen for this scholarship will be awarded a study abroad grant. As this Double Master program allows students to be exempted from Monash's tuition fees, the financial burden will be substantially lessened.
